2. In the past, I have faced criminal harassment, threats of injury and defamatory comments by the Respondent.



### Victim Impact Statement of Jessica Simpson

You've hurt me, repeatedly, and you do not care. You do not show any remorse for your actions and that scares me. As soon as you stepped out of court on October 13, 2021, you started talking about not abiding by your conditions and that you know you were breaching your conditions, you just didn't care. You have destroyed my life. You have caused me to attempt suicide, overdose, and not be able to sleep for weeks as I have extreme fears of your presence. I cannot walk on the streets without turning my back to see if you're behind me. You've put me into a constant panic and you do not care. You have not learned from your actions and what scares me is that you'll continue, and continue to put me into significant anxiety, fear, and depression. I've gone through a significant amount of injury due to you and you just don't stop. I hear about you being arrested on your YouTube, and then the next day you're out and calling female VPD police officers bitches and cunts. This shows me you'll never learn. It's to me like jail for you is a joke and you can meet your friends there. It's like you want to be in jail because they feed you and it's a free roof over your head. That is scary and that puts extreme fear into me that you'll now do anything to get arrested, without any remorse or thinking about your actions.

I am in constant pain due to fear and depression. I forget to take medications needed for my pain cause all I have is what you're going to do to me next on my mind, and that's affecting me significantly. You've done so much damage to me, it's unreal. You've gone onto your YouTube and you've defamed me calling me things such as pedophile, child groomer, child molester, fat fucking glut, fat fuck, and more. You've tormented my mother following us around town. You've called me 50 times a day for weeks in the middle of the night with harassing phone calls, causing me not to sleep and significantly affecting my health. You've spearheaded a campaign of abuse towards myself where people are making up false reports of being raped by myself in cities I've never been in, ever! Cities thousands of KM's away. You've caused me significant psychological trauma and I have self-harmed myself due to stress and fear involving you. Because of mental distress, you've caused me medical issues, which is a significant impact to me that you cannot even imagine due to my mental state caused due to you.

I live in a constant state of fear regarding you. I know that if you're not in jail, I am not safe. You do not respect the courts and you will not respect any conditions, no matter how significant they are. You put me into a constant state of fear regarding my safety and security. I have to have cameras that watch if you're coming by my property. I've had to notify my neighbors and building management about you and show them your picture and provide them with your warrants and conditions. I've had to put the RCMP on speed dial because of you and wear an emergency panic button. When I am with friends, I have to fear for their safety as you will harass them.

Being a woman is something really, really important to me. Throughout all of my life, people including yourself have tried to invalidate my identity and tell me that I'm not a woman. But I feel like I completely represent all of the qualities of femininity. If someone was meeting me for

the first time, I would introduce myself as fun, loving, an advocate, compassionate, a little bit goofy, but just an overall good friend, and a total queen. I have always been a little diva ever since I could express myself. I have always gravitated towards everything girly, and I was prancing around the house, dancing to music in girl clothes. Even though people thought I was a boy at the time, because no one knew I was transgender or what transgender was, I still was completely a girl in my heart and inside and out. As soon as I speak, I was saying "I'm a girl, I'm a girl." When I was 6 years old, I knew what gender I was and it was a major turning point in my life because I realized that my identity was valid as a girl, and that even though my parents had never heard of this before at such a young age, that all they could do was embrace and support me in order to make me happy. So with the love and support of my family, I was able to be my authentic self, and now today I'm the girl you see standing here. There are many transgender individuals out there, they don't have the love and support of their family or friends. While I have lost a lot of friends after coming out as transgender, my true friends and family are what matter most. They're really special people for allowing me to be my authentic self. Growing up in the public eye recently has completely transformed my life. I mean, I wouldn't be sitting in this chair right now if I didn't live the life that I've been living. One huge thing I believe in that it's okay to be different, because it just matters who you are.

However, Donald, with you constantly threatening and harassing me, I cannot live my life. Your constant attacks and violent threats towards me have affected me so much it's hard to regain my life back from all the damage you have caused. You scare me, and I wake up every day wondering if you're going to commit an offence towards me again. And that has been the constant. Every day you do another video, and you commit yet another offence towards me committing criminal harassment, defamatory libel, fear of injury, or uttering threats. Not a day goes by where I can relax and not be deathly scared of you.
