



You have been taking the same dose of metformin since january. YOU have vomited once today. You can keep liquids down

Our impression was:

Gastroduodenitis

Our advice to the patient:

This is most likely related to a viral infection. It is too early to tell if this is a sensitivity. You should consider dairy avoidance for a few weeks and see if your symptoms improve over 48 hours. Stay well hydrated and simple meals can be nourishing and better tolerated.

If things get worse, we advised:

If you are experiencing fever, increased abdominal pain, blood in the stools or vomiting, please get re evaluated by a doctor.



GGT is one of the enzymes produced by your liver. The value can reflect the work that your liver is doing. GGT may be elevated in people who consume higher amounts of alcohol or from certain medications. Sometimes elevated in people who are overweight, due to fat in their liver as well.

You communicated that you are a non-drinker.

You are wondering about getting testing done to screen for STI's. You are not currently sexually active, but want to be sure you are not a carrier of anything.

Our impression was:

Other nonspecific abnormal serum enzyme levels Sexually transmitted infectious disease

Our advice to the patient:

GGT level not worrisome. Talk to your doctor before starting any new medications and avoid alcohol where possible. I will send off a lab req for STI screening.

The patient told us:

Just started Saxenda 6 days ago and were started on the 0.6 mg dose; you injected 3.0 mg by mistake (5x the starting dose) and this was 4 pm yesterday and you ended in ER last night by ambulance; your blood sugar readings you told us were never in that true hypoglycemic range that causes symptoms, which is usually more in the 3.5 to 4.0 range in most people (especially below 3.0)

What we explored with the patient:

It is almost 24 hours since you injected and you still have nausea and acid reflux; we discussed that Saxenda helps people lose weight by suppressing the appetite but the dose needs to start low and go slowly up, as too much will go from suppressing the appetite to making you very nauseated and even may cause vomiting; as the medication is long acting I suspect it may be 1-3 days before you feel better; avoid spiced foods, alcohol, citrus Aspirin / Advil / Aleve (Tylenol is easier on the stomach) and don't keep loading up on sugar as the blood levels indicate this was not the cause of your nausea; if this were insulin it could have caused a severe hypoglycemic reaction and even coma and this is associated with a myriad of other symptoms such as dizziness, sweaty skin and cold skin along with blurred vision racing heart and pounding heart as your adrenal glands release a burst of adrenalin to try to bring the sugar levels up again; you did the right thing by calling the ambulance but I want to reassure you these types of medicines are relatively safe because they are unlikely to produce hypoglycemia as they do not work in the same way that insulin does; metformin is also known not to produce hypoglycemia either (but nausea and diarrhea are not uncommon)

You should not stop it with significant withdrawal symptoms. You have no self harm thoughts now - you are having insomnia currently.
