## What Happened? - Other

### **What led to this claim:**

- a) DURING THE TRIAL TAKEN BY JUDGE ALEXANDER ON NOVEMBER 8, 2016 9:30 AM AT COURTROOM 205, MR. BARRON THE DEFENDANT FALSELY CLAIMED THAT I TRADED WORK FOR 5% EQUITY IN "BOS LTD." INHOUSE MEDIA IN NEW WESTMINSTER FOR ANOTHER COURT CASE FOR 'SUBSTITUTE SERVICES PROVIDED' BY JY KNOWS IT BUSINESS CONSULTING.
- c) THIRDLY, MR. BARRON FALSIFIED THE SERVICE AGREEMENT DATED MARCH 16, 2016 IN WHICH HE VIOLATED CORPORATE LAW (SECTION 14) SIGNING AS A FICTITIOUS COMPANY NAME "BOS LTD."
